CORONAVIRUS/COVID-19 ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Elesia Chéree Ashkenazy/Ashkenazy Classical Ballet have put in place preventative measures to reduce the spread of COVID-19; however, there is no guarantee that you or your child(ren) will not become infected with COVID-19. Attending lessons with Elesia Chéree Ashkenazy/Ashkenazy Classical Ballet could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you and/or your child(ren) may be exposed to or infected by COVID-19 by attending ballet/dance lessons and that such exposure or infection may result in personal injury, illness, permanent disability, and death. You understand that the risk of becoming exposed to or infected by COVID-19 while taking ballet/dance lessons may result from the actions, omissions, or negligence of yourself and/or others, including, but not limited to, Elesia Chéree Ashkenazy/Ashkenazy Classical Ballet, volunteers, and program participants and their families.

You voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to your child(ren) or yourself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that you or your child(ren) may experience or incur in connection with attendance of ballet/dance lessons via Elesia Chéree Ashkenazy/Ashkenazy Classical Ballet, or participation in programming (“Claims”). On your behalf, and on behalf of your children, you hereby release, covenant not to sue, discharge, and hold harmless Elesia Ashkenazy/Ashkenazy Classical Ballet from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Elesia Chéree Ashkenazy/Ashkenazy Classical Ballet whether a COVID-19 infection occurs before, during, or after participation in any ballet/dance lesson. By registering and paying for any class, event, private lessons, or other activity offered by Elesia Ashkenazy/Ashkenazy Classical Ballet, you are agreeing to all of the above conditions and waivers.
